Methodological explanations	<p>Innovation activities are all scientific, technological, organisational, financial and commercial steps which actually, or are intended to, lead to the implementation of innovations. Some of these activities are themselves innovative, others are not novel activities but are necessary for the implementation of innovations. Innovation activities also include R&D that is not directly related to the development of a specific innovation.</p> <p>During a given period, an enterprise's innovation activities may be of three kinds: successful in having resulted in the implementation of a new innovation; ongoing, work in progress, which has not yet resulted in the implementation of an innovation and abandoned before the implementation of an innovation.</p> <p>Innovation survey is conducted on the basis of international methodology (Oslo Manual).</p> <p>Expenditures incurred on innovation activities in the scope of product and business process innovations include expenditures incurred in a given reporting year.</p> <p>All expenditures on product and business process innovations are taken into consideration in an innovation survey, that is, current and capital expenditures incurred within a reporting period on successful (i.e. having resulted in the implementation of an innovation), ongoing and abandoned activities, irrespective of their source of funding.</p> <p>Industrial enterprise is an enterprise that predominant activity was included in the industrial sector according to NACE Rev.2 - PKD 2007 classification, i.e. into one of four sections B - Mining and quarrying, C - Manufacturing, D - Electricity, gas, steam and air conditioning supply and E - Water supply; sewerage, waste management and remediation activities.</p> <p>Data concern listed service sector enterprises according to Nace, Rev. 2 classification:</p> <p>Section G Wholesale and retail trade; repair of motor vehicles and motorcycles</p> <p>» Division 46 Wholesale trade, except of motor vehicles and motorcycles</p> <p>Section H Transportation and storage</p> <p>» Division 49 Land transport and transport via pipelines</p> <p>» Division 50 Water transport</p> <p>» Division 51 Air transport</p> <p>» Division 52 Warehousing and support activities for transportation</p> <p>» Division 53 Postal and courier activities</p> <p>Section J Information and communication</p>
